When I posted it on alt.security.terrorism usenet group on ( URL 1) NOV-28-10, Honorable President went on SURPRISE visit to Afghanistan within hours. IMO, Reason of the surprise visit was not related to national security even remotely. White house has not responded to my query in this matter till now. What is the reason for none of the parties mentioned on the posting to reply publically?

I suspect slide set of Cashless Economy was misused by Khosla Ventures. When I posted on ietf@ietf.org on JUL-12-11 (URL 2) and JUL-15-11 (URL 3) with Khosla Ventures and Nobel on the list, then none denied the charges.

When my emails cleanup / manipulation etc was done by hosted email service provider including google, and I checked the contents of posting (URL 1) on my mobile on APR-22-11, then Bin Laden was dead within 8-10 days. With all respect to soldiers / humans fighting against terrorism, I strongly suspect that someone knew very well whereabouts of Bin Laden in advance. I tried to post this on alt.security.terrorism group (URL 4) from another a/c. This email did not show up in the email sent to other subscriber of the news group. Either google hosted news server buggy at that point of time for my a/c, or someone else deleted that. (I doubt this.) It makes my suspicion about prior knowledge of whereabouts of Bin Laden "STRONGER". Refer video of mobile (I sent URL to myself at that time) on URL 5. I suspect afterwards counters (traffic) might have manipulated on the mobile too when I mentioned this on the email.

I have been facing lot of issues since I started working on Cashless Economy. I strongly suspect that I was under audio / video surveillance via compromised fire sprinklers in my apartment, Reporting of which to Sunnyvale Public Safety, FBI, District Attorney did not result in proper investigation by taking them out. Refer case 111CV205808 at URL 6, which was due to me holding the evidence. Judge ordered eviction in this case. I was kicked out of the apartment. Case info on URL6 doesn't even show my detailed reply sent to Judge for the reason of not appearing in the court.

I have not taken bath/ shaved / changed cloths since months to avoid fabricated case by edited video. It has forced me to live in reduced human rights environment. Reporting to UN Human rights council did not result in any reply from them. I request pictures/ encrypted time-stamped video to be captured first of my current conditions by Law Enforcement, so that I can start my normal life.

Due to misuse of slide set by Khosla Ventures for Nobel Prize to Honorable President, the breakthrough work of Cashless Economy, Complete Multimedia Recordings has got stuck. (Refer my blog at <http://samirsrivastava.typepad.com>) and resulted in me being followed up like anything. I cannot get proper legal advice timely. Therefore I am writing to you without proper legal forms etc.

I am seeking trial/ impeachment of Honorable U.S. President. I can testify before any committee and court of law. I am seeking resignation of Head Of Sunnyvale Public Safety, FBI, and U.S. President to let independent probe to happen, as evidences can be manipulated.

I am Indian citizen with Permanent Residency (Green Card) in U.S. I came to U.S.A. in 1998. I have B. Tech. in Computer Science & Engg (1990) from H.B.T.I. Kanpur. I worked at various leading/start-up companies such as C-DOT (New Delhi – India), Hewlett Packard (Bangalore – India), Level (3) Communications U.S., Nortel Networks U.S., adomo U.S., Nuera Communications U.S., Litescape Technologies U.S. I contracted at Bell Labs and Cisco Systems. I held positions of Software Engineering
